Clean Router Software License Agreement Single Use License

Any software originating from CleanTechnology, Inc (CT) and its suppliers is licensed under this Agreement. You may also be prompted to review and accept this agreement upon installation of the hardware.

PLEASE READ THIS SOFTWARE LICENSE AGREEMENT (LICENSE) CAREFULLY BEFORE USING THE PANDORA'S HOPE SOFTWARE.

THIS LICENSE AGREEMENT IS BETWEEN YOU AND PANDORA'S HOPE LLC ("CT"). BY DOWNLOADING OR INSTALLING THE SOFTWARE, OR USING THE PRODUCT CONTAINING THE SOFTWARE, YOU ARE CONSENTING TO BE BOUND BY THIS AGREEMENT. - A. <u>Transfer</u>. This license may not be sublicensed, and is not transferable. You may not rent, lease, lend, sell, redistribute or sublicense the CT Software.
- B. <u>Definition</u>. "Software" includes, and this Agreement will apply to (a) the software of CT or its suppliers provided in or with the applicable CT product, and (b) any upgrades, updates, bug fixes or modified versions ("Upgrades"), provided you already hold a valid license to the original software and have paid any applicable fee for the Upgrade.
- C. <u>Software Description</u>. The CT Software automatically blocks sites, displays, links to third party web sites and other information located worldwide throughout the Internet. The CT Software does this by using various levels of filtering.
- 2. <u>Protection of Information</u>. The Software and documentation contain trade secrets and/or copyrighted materials of CT or its suppliers.
